### Introduction

The website <u>www.processmind.com</u> (the "Website") utilizes cookies, including those from third parties. This policy aims to inform you about how cookies are employed on this website and the ways in which you can manage them.

At ProcessMind, we leverage cookies to enhance your browsing experience and to tailor our services to your specific needs and interests. Certain cookies are essential for functionalities such as logging in, storing your preferences, and ensuring the correct display of our web pages.

Additionally, other cookies provide us with invaluable insights into the usage of the Website. This allows us to improve its efficiency and make it more user-friendly.

## **Cookie List**

A cookie is a small piece of data (text file) that a website—when visited by a user—asks your browser to store on your device in order to remember information about you, such as your language preference or login information. Those cookies are set by us and called first-party cookies. We also use third-party cookies—which are cookies from a domain different than the domain of the website you are visiting—for our advertising and marketing efforts. More specifically, we use cookies and other tracking technologies for the following purposes:

#### **Strictly Necessary Cookies**

These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personally identifiable information.

This table organizes each cookie by its name, function, content, and expiration timeframe, making it easier to understand their purpose and duration.

#### **Analytics cookies**

These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our site, and will not be able to monitor its performance. These are non-essential cookies controlled by the cookie banner. If you're a visitor to a site, you can opt out of these cookies by not giving consent.
